NURSES AND MIDWIVES (FEES) REGULATIONS, 2019

IN EXERCISE of powers conferred by section 85 of the Nurses and Midwives Act, I  
JAPPIE CHANCY MTUWA MHANGO, Minister of Health, make the following Regulations—

| Citation   | 1. These Regulations may be cited as the Nurses and Midwives (Fees) Regulations, 2019.  |
| Fees   | 2. The fees set out in the Schedule hereto shall be payable in respect of the matters to which they relate.   |
| Failure to renew registration                            | 3. Any registered person who does not renew the membership with the Council by the prescribed date shall not be allowed to practice anywhere in Malawi and the Council shall remove his name from the register.   |
| Renewal of registration after being barred from practice | 4. Where a person who has been barred from practice wishes to be restored in the Register and renew membership, the person shall pay in addition to the penalty, the prescribed registration fees as prescribed in the Schedule hereto for each period not. |
| Revocation of GN. 4/2005                                 | 5. The Nurses and Midwives (Fees) Regulations are hereby revoked.   |
