

NURSES AND MIDWIVES ACT (CAP. 36:02) NURSES AND MIDWIVES (FEES)
(AMENDMENT) REGULATIONS, 2026

IN EXERCISE of the powers conferred by section 85 of the Nurses and Midwives Act, I, MADALITSO BALOYI, Minister of Health and Sanitation, with the advice of the Council, make the following Regulations—

1. These Regulations may be cited as the Nurses and Midwives (Fees) Citation
(Amendment) Regulations, 2026.

2. The Nurses and Midwives (Fees) Regulations are amended, by Replacement deleting the Schedule and replacing therefor, a new Schedule, as follows—
